### KEY ISSUE:

To provide an update on recent Source Protection Committee activities.

## **RECOMMENDED RESOLUTION:**

RESOLVED, THAT, the update on Source Protection Committee activities be received.

Since our last Source Protection Authority (SPA) meeting held on April 20<sup>th</sup>, 2023, the Source Protection Committee (SPC) met on June 26<sup>th</sup>, and November 1, 2023. This report summarizes the key topics discussed and outcomes of those meetings. The meeting summaries produced for the SPC meetings are attached for information.

## **Chair's Reports**

Chair Jim Hunt provided reports to the Committee on the one-on-one meeting that was held with MECP Source Protection Programs Branch Director, Kirsten Service, discussing the source protection program moving forward. He also updated the Committee on a letter which was send to the new Minister of the Environment, Conservation and Parks, Andrea Khanjin, by the Chair of the Quinte Source Protection Committee expressing concern for the lack of rural source water protection legislation in place. Mary Wooding, MECP Liaison Officer, shared that the MECP intends to maintain open dialogues with Source Protection Regions and Chair.

## **Best Management Practices for Other Systems**

The Committee was provided an update on best practices to protect source water for landowners, including work that has been done and future projects including a webinar program. The Committee was pleased with the education and outreach value of the program.

## **Pre-Consultation on Source Protection Plan Amendments**

The Committee reviewed all the comments received during pre-consultation phase of the Section 36 Amendment Process, which lasted from May 1 to May 30, 2023. Comments were received from groups including Transport Canada, OMAFRA, Risk Management Officials, Trans Northern Pipeline Inc., and the Source Protection Authority Municipal Working Groups. All comments were received for information by the Committee, with some resulting in minor

edits to policy wording and a few resulting in major changes to the policy wording.

## Public Consultation Source Protection Plan Amendments

The Project Manager summarized the public consultation process, which ran from September 10 to October 10, 2023. Notices of the public consultation were posted in four newspapers, as well as social media and the local conservation authority websites. Direct mailouts were sent to all impacted landowners, and hard copies of the notices were available at local conservation and municipal offices. Comments were received for both the Trent and Ganaraska Assessment Reports and Source Protection Plans and upon review, minor edits were made to the policy text.

## Next Steps

The approvals process for Section 36 Amendment was summarized for the Committee. The amendment package went through review for AODA compliance prior to its formal submission to the Ministry of the Environment, Conservation, and Parks on December 20, 2023. At the time of writing this report, the Ministry has not approved the amendment, and the timing of their approval is unknown.

Following an anticipated approval of the amendments, implementation would involve expansion of education and outreach efforts, working with municipalities in the adaptation of new policy and technical rule updates, improving the annual reporting process, and improving internal documents on the processes for transport pathways and Risk Management Official protocols/methods.

The Project Manager suggested that it would be beneficial to invite guests to future Committee meetings, including indigenous representatives, pipeline companies, agricultural experts, emergency responders, road salt experts, fuel experts, water treatment experts, and septic inspectors. Staff turnover across municipalities and conservation authorities across the region highlighted the need for succession planning for both staff and committee members as a priority, along with the retaining existing recruitment and improving training processes.

## Round Table Updates

Committee members were invited to speak on any items they felt the Committee would be interested in hearing about. Crowe Valley Source Protection Area municipal representative, George Offshack, expressed an interest in increasing municipal engagement within the program, specifically due to many municipalities within the Region experiencing high rates of staff turnover in recent years. He also wanted to make the Committee aware of an individual in the region donating roughly 21,000 acres to the Nature Conservancy of Canada. The Environmental Non-Government Representative, Phillip Niblett, provided an overview of the Baxter Creek Watershed Alliance meeting he attended. He noted a primary concern was on non-municipal drinking water sources, adding that the Chief of Alderville First Nation spoke, as well as students from local colleges and universities, on water studies being completed.

The Waterfront Landowners Representative on the Committee, Terry Rees, spoke about some early discussions he has been having with MECP and the Federation of Ontario Cottagers Association regarding a rural source protection plan. He also provided a summary of a Road Salt Seminar he attended, which included contractors, researchers, consultants, conservation authority, and municipal staff. Discussions involved lake studies, issues regarding liability, certification, and training.

## Leads Reports

At each Committee meeting, the Leads of each Source Protection Area gave an update on the status of program implementation within their area. These reports help to identify challenges or areas in which the Committee may support the Leads. These updates included details of the status of all remining Risk Management Plans, current issues or challenges, status updates on any Section 34 amendments, positive progress or news, and the successes or challenges of the current education and outreach efforts. These updates were received for information.



# SOURCE PROTECTION COMMITTEE (SPC) MEETING SUMMARY JUNE 26, 2023 – ASPHODEL-NORWOOD COMMUNITY CENTRE

#### **CHAIRS REPORT**

 J. Hunt noted there was a one-on-one meeting with Ministry of the Environment, Conservation and Parks (MECP) Source Protection Branch Director, Kirsten Service discussing the source protection program moving forward. M. Wooding shared MECP intentions to maintain open dialogues with Source Protection Regions and Chairs.

#### LEADS REPORT

- Each Source Protection Authority (SPA) Lead Staff member provided a verbal report on the status of their local source protection implementation, including:
  - a. Training of new municipal staff regarding the source protection program;
  - b. Update on municipal working groups and their comments on the proposed s.36 Amendments;
  - c. Update on risk management plans and RMO progress;
  - d. Current issues or challenges;
  - e. Positive progress news;
  - f. Update on education and outreach efforts.

#### PRE-CONSULTATION COMMENTS AND RECOMMENDATIONS FOR THE SECTION 36 AMENDMENTS

- K. Taylor provided an overview of the comments received during the pre-consultation phase of the S.36 Amendment. This phase includes comments from implementers of the Source Protection Plan, including: Transport Canada, OMAFRA, Risk Management Officials, Trans Northern Pipeline Inc., and the Source Protection Authority Municipal Working Groups.
- K. Taylor brought forward a number of motions, including comments received as information with no changes to the Source Protection Plan, and a number of minor and significant changes proposed to the Plan.
- OMAFRA provided three comments, regarding policies A-2 and A-3, A-4, and N-1.
- The RMO from Marmora, and Source Protection Program Manager from Quinte Conservation, Amy Dickens, provided general comments and a suggestion for policy O-1(3) regarding snow dumps.
- Trans Northern Pipeline Inc. (TNPI) provided comments on policies G-6(6) (Signage), HP-2 (water crossings), HP-5 (location of equipment near watercourses), HP-6 (conservation authorities), HP-8 (requests for information on integrity inspections and maintenance) and HP-9 (moderate and low-threat policy).
- P. Niblett inquired for further information on the "current industry best practices" suggested to include in policy HP-5. K. Taylor suggested that TNPI would be willing to attend

a future meeting to provide more information regarding this, and that this information is available online.

- K. Taylor reviewed the comments received from Risk Management Officials Terri Cox (Otonabee-Peterborough SPA), Jenna Stephens (Kawartha-Haliburton SPA) and Marcus Rice (Lower Trent SPA) regarding the proposed amendments on Policies F-2(2) - Fuel, O-1(3) – Snow Storage, O-2 – Snow Storage, O-3 – Snow Storage, A-4 – Agriculture (including pesticide exemption), D-1, D-2, D-3 - DNAPLs, and R-1(1) – Road Salt.
- K. Taylor provided an overview of the comments received from the Kawartha-Haliburton Municipal Working Group on policies S-6 Sewage Systems, A-2 and A-3 Agriculture (including pesticide permits, the impact on future land-owners, and the impact on non-agricultural land), R-1(3) and R-1(4) and R-1(5) Road Salt.

#### **NEXT STEPS**

• K. Taylor provided an overview of the next steps involved in the S.36 Amendment, including making necessary changes to the policies based off pre-consultation comments, and Source Protection Committee approve moving forward to the Public Consultation Stage.

#### **INCREASING MUNICIPAL ENGAGEMENT – GEORGE OFFSHACK**

• G. Offshack inquired about increasing municipal engagement in areas with a lot of municipal staff turnover, small municipalities and low turnout and engagement in municipal working groups such as in Crowe Valley CA. Staff discussed the potential merging of Crowe Valley's municipal working groups with Lower Trent's in the future.

#### **BEST PRACTICES FOR OTHER SYSTEMS**

- T. Bos provided a report on the Best Practices Program to the committee, including work that has been done and future projects including a webinar program.
- F. Langmaid suggested incorporating "Drinking" into the title (Drinking Water Wise, etc.).

#### ROUNDTABLE

- G. Offshack noted an individual in the region donating roughly 21,000 acres to the Nature Conservancy of Canada.
- P. Niblett inquired about an orientation session for new SPC members and any materials needing to be signed. K. Taylor noted staff will be in touch regarding setting up a meeting shortly, and those documents will be passed along.

#### NEXT MEETING

• K. Taylor noted there is no set date as of now, but likely after the 35-day Public Consultation period in late October.

# SOURCE PROTECTION COMMITTEE (SPC) MEETING SUMMARY NOVEMBER 2, 2023 – ASPHODEL-NORWOOD COMMUNITY CENTRE

#### **CHAIRS REPORT**

 J. Hunt noted there hasn't been a chairs meeting since the last SPC meeting, however talked about a letter sent from Max Christie, Chair of the Quinte Source Protection Committee, to the new Minister of the Environment, Conservation and Parks, Andrea Khanjin, expressing concern for the lack of rural source water protection legislation in place.

#### LEADS REPORT

- Each Source Protection Authority (SPA) Lead Staff member provided a verbal report on the status of their local source protection implementation, including:
  - Update on public consultation efforts on the proposed s.36 Amendments, including targeted social media posting, newspaper ads, and mail-outs;
  - Update on municipal working groups;
  - Update on risk management plans and RMO progress, managing new threats;
  - Current issues or challenges;
  - Positive progress news, such as Otonabee Conservation updating their webpage;
  - Progress on updating municipalities on the upcoming Annual Reporting process;
  - Update on education and outreach efforts, events.

### PUBLIC CONSULTATION REVIEW, COMMENTS AND RECOMMENDATIONS FOR THE SECTION 36 AMENDMENTS

- K. Taylor provided an overview of the comments received during the pre-consultation phase of the S.36 Amendment. This phase includes comments from implementers of the Source Protection Plan, including: Transport Canada, OMAFRA, Risk Management Officials, Trans **REVIEW:**
- K. Taylor provided a Summary of the public consultation phase of the S.36 Amendment. Noting the 35-day period has completed, and that notices were placed in four newspapers, as well as social media posting, and a question and comment form setup online where the revised documents and proposed changes were viewable. Hard copies of the documents were also available at Conservation Authority offices. K. Taylor provided an overview of some of the questions and comments received over phone calls, and the questions and comments submitted through the online question form.
- PUBLIC COMMENTS RECEIVED:
- K. Taylor provided an overview of the public comments received through the official submission form. This included a general comments unrelated to specific policy changes, such as expropriating green space and farmland for development, a comment regarding where to find a map showing private well locations and records, and a comment regarding the lack of hazardous waste disposal locations in some communities.
- IMPLEMENTERS COMMENTS RECEIVED:

- K. Taylor noted one comment was received from Trans North Pipelines (TNPI), indicating that they had no further comment since their previous comments were dealt with by the committee. They also thanked the committee for the opportunity to review.
- P. Niblett noted his concerns regarding the lack of information provided on the best management practices from Trans Northern Pipelines, suggesting the wording is vague and insufficient. K. Taylor suggested the committee could reach out to TNPI to speak at a future meeting, as they have done in the past.

#### **GENERAL COMMENTS:**

- K. Taylor addressed comments that were received from the Ministry of the Environment, Conservation and Parks on the Source Protection Plans and Assessment Reports, including:
  - Updating all tables to ensure references to the Table of Drinking Water Threats (i.e., 2013/2017) be updated to reference the Technical Rules (2021), and to ensure the year of the Technical Rules is referenced throughout.
    - K. Taylor noted staff did use the 2021 Technical Rules to revise the Table of Drinking Water Threats in the Assessment Report.
    - K. Taylor noted most of the technical work was done using the 2013, however some updates were done using the 2021 rules, and these will be referenced in the documents.

#### **TRENT ASSESSMENT REPORT:**

- Ensuring Sections 4.4.3, 5.4.3, and 6.3.2 in the Assessment Report list the six occurrences per Technical Rule 126 where contaminated sites may be identified as Conditions. And removing reference to a WHPA-F in the footnote of Table 8-2.
  - K. Taylor noted these minor errors were corrected.
- Recheck the enumeration of the road salt application risks for the Kinmount drinking water system, where the impervious surface areas vary between 6-8% in IPZ-1 with a vulnerability score of 10.
  - K. Taylor noted two Road Salt Application threats will be added for Kinmount because there are two County Roads that are now significant threats under the new rules and the new impervious percentage calculation.

#### **GANARASKA ASSESSMENT REPORT:**

- Removing all references to the old provincial tables of circumstances.
- Providing details supporting the proposed extension to the IPZ-2 of the Cobourg drinking water system. K. Taylor noted Ganaraska staff has provided support in completing this, including more detailed text explaining the rationale and method for expanding the IPZ-2 to be added to the document.

#### **COMMENTS ON THE UPDATED SOURCE PROTECTION PLANS**

• Revising the wording of Policy G-6(6) regarding pipeline signage for clarity, from "visibly noticeable" to "visible."

- K. Taylor explained that the MECP would like the waste disposal prescribed drinking water threat activity to be first on the list of activities in the updated Policy G-7(2).
- K. Taylor addressed comments received from MECP regarding policy G-8(1) concerning risk management plan timelines, as a follow-up to comments received during Early Engagement. After further review it was determined to re-add the wording "within 2 years of the effective date of the plan or plan amendment" to the Policy G-8(1) text.
- K. Taylor provided an overview of minor wording corrections noted by MECP to the Trent and Ganaraska Source Protection Plans, for clarity, to be completed by Ganaraska and regional staff. These changes did not alter the intent of any policies.
- K. Taylor reviewed the comments received from Meredith Carter and Terri Cox (Otonabee Conservation), concerning removing "and future" from policy G-1(4), adding "complete" to "application" in the Policy G-1(2), and amending Policy F-1 and F-2 to only prohibit the future handling and storage in IPZ-1 and require Risk Management Plans for future fuel threats in IPZ-2. All proposed amendments were approved.

#### **ADDITIONAL COMMENT**

- K. Taylor noted he met with Jennifer Mckay and Erin Harkin recently concerning the minimum requirement for prescribed instrument policies, with a concern over a lack of information provided on these in the Ministry's annual reporting. The ministry suggested removing the minimum requirement. K. Taylor had suggested that the Prescribed Instrument must include as a minimum, what vulnerable area the managed activity is in and what emergency measures are in place related to protecting the drinking water source.
- J. McKay noted more written comments have been provided, sent out the morning of the SPC meeting to K. Taylor. The latest memo provides additional clarity regarding these prescribed instruments. M. Wooding noted existing environmental compliance approvals have all been addressed, and it is not feasible to go back and revise those. K. Taylor suggested that all future approvals meet that minimum standard, and the annual reporting describe where these are taking place specifically.
- K. Taylor recommended we leave the wording as is, with the understanding that the Ministry make efforts to improve the level of information regarding this shared during annual reporting. K. Taylor is to distribute the updated memo to the committee.

#### **NEXT STEPS**

• K. Taylor provided an overview of the next steps involved in the S.36 Amendment, including final submission to the Ministry of the Environment, Conservation and Parks.

#### WHAT HAPPENS AFTER THE SECTION 36 AMENDMENTS

 K. Taylor provided a summary of the possible tasks for the staff and committee members following the completion of the S.36 amendment. This includes: expanding education and outreach efforts and including committee members in this; working with municipalities on adapting to the new policy and technical rules updates; improving the annual reporting process; and improving internal documents on the processes for transport pathways and RMO protocols and methods.

- K. Taylor also recommended inviting guests to SPC meetings, such as indigenous representatives, pipeline companies, agricultural experts, emergency responders, road salt experts, fuel experts, water treatment experts, septic inspectors.
- Other activities included field trips to municipal drinking water systems, water treatment plants etc.
- K. Taylor noted the need for further turnover and succession planning for both staff and committee members, noting a recruitment and orientation process is in place but could be improved.

## BACKGROUND

The *Clean Water Act* and associated general regulation 287/07 identify reporting requirements specific to the Source Protection Authority (SPA). There is a need to report to the Minister of the Ministry of the Environment, Conservation and Parks (MECP) on progress related to Source Protection Plan (SPP) implementation.

The SPP created by Source Protection Committees (SPC) also contain a number of reporting policies that must be reported to the SPA annually. This information is aggregated by staff representing the SPA from each of the implementing bodies and summarized, resulting in the content for annual progress report.

## ANNUAL PROGRESS REPORT

O. Reg. 287/07 of the *Clean Water Act* outlines the requirements for the Source Protection Region (SPR) to submit an annual progress report to the MECP. This annual progress report contains implementation information for 2023, which must be submitted to the Minister of the MECP by May 1, 2024. Each SPR must submit one report per source protection plan (SPP). The region has two SPPs (Trent and Ganaraska), and as such, the Trent SPR will be submitting two reports.

The information to be contained within these reports has been dictated by the MECP in

a detailed Supplemental Report, and a simpler "public-facing" document. The "public – facing" document has been designed to summarize the information in the supplemental document into a more digestible format for general communication purposes.

As of 2021 the Trent Conservation Coalition Source Protection Region has moved away from excel documents which have previously been used to collect annual report information from local implementing bodies and has changed to an online electronic reporting format. The online reporting format is supported by the MECP and Conservation Ontario. Two training/refresher webinars were held in early 2024 for all municipal staff who complete the annual report for their municipality.

SPA staff have compiled applicable information at a broadly summarized scale for the Kawartha-Haliburton Source Protection Area (Attachment – KHSPA Annual Progress Report).

Once this report is approved by the Kawartha-Haliburton Source Protection Authority Board of Directors (K-H SPA BOD), it is then rolled into a regional annual progress report which will be presented to the SPC for comment and endorsement on March 26, 2024. Due to tight timing on this front, the draft K-H SPA annual progress report has been incorporated into the regional annual progress report. This regional annual progress report will be submitted to the K-H SPA BOD for endorsement on April 25, 2024, which will allow the lead SPA, Lower Trent, to submit the annual progress report to the MECP by the May 1, 2024, deadline.

## ANNUAL PROGRESS REPORT GRADING

The annual progress report for the K-H SPA has been completed using a public facing document template provided by the MECP. Within this document there are 5 sections which require a grade to be assigned (P: Progressing well/on target, S: Satisfactory, or L: Limited progress made) to assess implementation progress as identified below:

- Municipal Progress
- Septic Inspections
- Risk Management Plans
- Provincial Progress
- Awareness and Change in Behaviour

The following ratings and summary of implementation measures proposed:

## **Municipal Progress:**

Municipalities and approval authorities under the *Planning Act* are the implementing body for 56 policies in the Trent SPP.

All municipalities have established standard operating procedures to ensure day-to-day planning decisions conform to the SPP. Four municipalities have completed amendments to their Official Plans and Zoning By-Laws, ensuring that they conform to the SPP. The remaining municipalities have their amendments in progress and will have them finalized within the timeframe specified within the SPP. All municipalities have confirmed that updates to their Emergency Management Plans are complete, ensuring that they conform to the SPP.

A rating of *P: Progressing Well/On Targe*t is suggested.

# Septic Inspections:

The Ontario Building Code (OBC) requires that septic system threats be subject to a mandatory inspection program within a drinking water protection zone.

Within the K-H SPA, the septic inspections are completed by the municipal building inspectors or chief building inspectors. All existing septic threats (365) were inspected in the first 5-year phase, of which 301 (83%) passed with no maintenance required, 51 (14%) passed with minor maintenance required, and 12 (3%) failed and required major work such as replacement. All septic systems are now in the second 5-year inspection phase. Of the 365 existing septic threats, 309 have been inspected to date, 20 (6.5%) of which required minor maintenance and 9 (3%) of which required major maintenance.

A rating of *P: Progressing Well/On Targe*t is suggested.

## Risk Management Plans:

Risk Management Officials (RMOs) are the Implementing Body for 39 policies in the Trent SPP and utilize the following tools which were established under Part IV of the Act, to manage threats: Prohibition (s.57); Risk Management Plans (s.58); and Restricted Land Uses (s.59).

The total number of Risk Management Plans (RMPs) established in the Kawartha-Haliburton SPA in 2023 was 0, maintaining the total number of RMPs at 47. These 47 plans collectively manage a total of 445, or 98% of the 454 significant drinking water threats initially enumerated in the Assessment Report. The outstanding RMPs are not subject to the established deadlines due to changes in property ownership and vulnerable area mapping. Work to complete these RMPs is ongoing.

The total number of inspections carried out by a Risk Management Official/Inspector is 6. The RMOs will now be inspecting all RMPs on the same schedule, once a year. The compliance rate with the risk management plans established is 100%. As a result of these inspections, it was found that some RMPs need to be revoked due to change in property ownership or cessation of the threat activity on the property. RMOs are working to revoke these RMPs on an ongoing basis.

RMOs within the K-H SPA issued 21 Section 59 notices in 2023 for a total of 163 Section 59 notices since the effective date (January 1, 2015) of the Trent Source Protection Plan. The processes to screen development applications are reported to be working well and some municipalities continue to fine tune their screening processes to improve efficiencies.

A rating of *P: Progressing Well/On Target* is suggested.

## **Provincial Progress:**

Five provincial ministries reported on progress of 27 policies in our SPP. The ministries have implemented 90% of the TCC policies. The remaining 10% are reported to be in progress, however these are on items such as "Continue ongoing investigation and implementation of innovative practices and mitigative technologies..." and therefore will most likely always be marked as in progress.

## Source Protection Awareness and Change in Behaviour:

Signage was identified as an effective tool for raising awareness of the Drinking Water Source Protection (DWSP) program and the importance of protecting sources of municipal drinking water. Prior to 2021, 60 Drinking Water Protection Zone signs have been installed in the Kawartha-Haliburton SPA; 4 on Provincial highways, and 56 on municipal and county roads.

RMOs attended in-person events such as the East Central Farm Show and the Country Living Show. As usual, the vulnerable area maps and Drinking Water Protection Zone road sign were a great draw for people walking by.

As part of the Section 36 amendment process, staff from across the Trent Source Protection Region participated in the consultation phases, including public consultation. As part of the public consultation phase, the City of Kawartha Lakes RMO sent direct mailouts to all landowners and tenants who would be impacted by the proposed changes. This was seen as the most direct and cost-effective way to ensure that the information about the amendments reached the intended audience. Very few mailouts were returned to the sender, and those that did were hand delivered to the new property owners. No comments were received through this consultation effort.

## A rating of *P: Progressing Well/On Targe*t is suggested.

## SUMMARY AND OVERALL PROGRESS GRADE

All required annual reports from implementing agencies have been received and all reporting requirements for 2023 have been met; should annual reports from individual implementing bodies be required, staff would be pleased to provide them upon request.

The grading suggested for each of the implementation categories is summarized below. As illustrated, the categories all score a grade of Progressing Well/On Target -- a similar grade for the overall grading of implementation progress is recommended.

# II. A message from your local Source Protection Committee

On behalf of the Trent Conversation Coalition Source Protection Committee, it is my pleasure to introduce the 2023 Annual Progress Report on the implementation of the Trent and Ganaraska Source Protection Plans. We have now completed 9 years of implementation and it is encouraging to see our Source Protection Plan Policies being implemented across our vast region.

It is hard to believe that we are approaching the 24th anniversary of the Walkerton water tragedy. As a result of that series of tragic events, we have learned lessons and we are now and better equipped to deal with potential future perils. The Source Protection Program in Ontario is a perfect example of how we can learn from adversity and reduce the risk of history repeating itself. But we must never become complacent. This Annual Report provides a snap shot of where we are in the program and details of how the Source Protection Plans are being implemented.

As always, our main objective is to protect sources of drinking water. This concept of source water protection was identified as the first barrier in a multi-barrier approach to safer drinking water by the Walkerton Commission. Our assessment reports and Source Protection Plans are science-based and as new science emerges our staff and committee will respond with appropriate amendments.

I am pleased to announce that in December, 2023, an extensive amendment package under section 36 of the Clean Water Act, 2006, was submitted to the Ministry of the Environment, Conservation and Parks for approval. This effort was the culmination of 5 years of research and consultation to adapt to new Technical Rules and to address some policy changes. Our Source Protection Committee reviewed and approved all the amendments.

In 2023, our regional staff also continued to provide expertise to people who do not receive their water from municipal systems. Our stance has always been that everyone should have safe drinking water. We are working with other Source Protection Regions in Eastern Ontario to provide webinars that explain best practices to assist people with private drinking water systems. We hope to continue this program into the future.

Our Annual Report summarizes the achievements of the Risk Management Officials, the municipalities and the provincial ministries that are required to implement the many policies in our Source Protection Plan. Through this exercise the committee can judge the level of progress made and the effectiveness of the Source Protection Plan policies as well as identify any challenges with implementing the Plan.

Each year, as we prepare these Annual Reports, there is an opportunity to reflect on the magnitude and importance of the work we do to protect sources of municipal drinking water. I encourage you to read this report to follow our progress.

# Kawartha-Haliburton Source Protection Area

The Kawartha-Haliburton Source Protection Area is comprised of watersheds that represent the jurisdiction of Kawartha Conservation, and an additional watershed area to the North primarily within Haliburton County.

The K-H SPA covers an area of 5,406 km<sup>2</sup> and is located within the southcentral region of Ontario, fringing on the Greater Toronto Area to the south and Algonquin Park to the north. There are 11 municipalities within or partially within the Source Protection Area.

There are six existing municipal residential drinking water systems in the source protection area that obtain their water from surface water sources. These systems serve about 22,350 people and include:

The jurisdictions of 43 municipalities lie within the TCC SPR, however of those, 27 municipalities (22 lower tier and 5 upper tier) contain vulnerable areas where SPP polices apply. There are 19 municipalities located within or partially within the Kawartha-Haliburton SPA; 14 lower tier, 4 upper tier and 1 single tier municipalities in the Kawartha-Haliburton SPA.

All municipalities (100%) within the SPA have established standard operating procedures to ensure day-to-day planning decisions conform to the SPP. Some fine tuning of the process is required to ensure all relevant applications are flagged and transport pathway notifications occur to ensure that planning advice is provided to manage or provide options to manage potential transport pathways.

67% of the municipalities have completed amendments to Official Plans and Zoning By-Laws, ensuring that they conform to the SPP. The remaining municipalities have their amendments in progress with plans in place to complete the updated within the timeframe specified in the Trent SPP.

All of the municipalities (100%) have implemented updates to Emergency Management Plans are complete, ensuring that they conform to the SPP.

Based on the location of individual septic systems, the responsibility to undertake these inspections may be that of the local Health Unit/department, municipality, or Conservation Authority depending on which body is empowered by the principal authority (municipalities).

A total of 100% (364) of existing septic threats have been inspected in accordance with OBC in the first inspection period, of which 83% passed inspection and are functioning as designed or carrying out the required pump-outs. 14% required minor maintenance such as a pump out or lid replacement, and 3% needed major work such as tank replacement. All systems are now in the second 5-year inspection period and inspections will begin following the same schedule which was used for the first round of inspections. Compliance dates for existing threats are set by the s. 1.10.2.4 (2)(a)(i)(A) of <u>O. Reg.</u> <u>315/10: BUILDING CODE</u> to be five years after the date of publishing of the Assessment Report on the Environmental Bill of Rights, November 3, 2014.

Within the second 5-year inspection period, 309 of the now 365 septic threats have been inspected. Of the systems inspected, 20 (6.5%) needed minor maintenance such as a pump out or lid replacement, and 9 (3%) needed major work such as tank replacement. The remaining system inspections will be completed before the end of the current 5-year inspection period. Municipalities have indicated that, if necessary, the inspections will be completed through a legal order.

100% of municipalities and/or health units have standard operating procedures to ensure OBC compliance and thus ensure that future septic systems do not become significant threats.

In accordance with O.Reg. 288/07 under the *Clean Water Act, 2006*, the Trent Conservation Coalition Source Protection Region may be composed of up to 21 members, one third of which must be municipal representatives. As the Kawartha-Haliburton Source Protection Area contains more drinking water systems than any of the other four Source Protection Areas within the Trent Source Protection Region, it is permitted to have two municipal source protection representatives on the Source Protection Committee.

In March 2023, Municipality of Highlands East councillor, Cecil Ryall, was named as a municipal member of the Source Protection Committee representing the municipalities within the Kawartha-Haliburton Source Protection Area. In April 2023, City of Kawartha Lakes Supervisor, Policy Planning, Paul Pentikainen, was named as the second municipal member on the Committee.

In August 2023, Paul accepted an exciting out-of-country career opportunity, leading to him stepping down from his role on the Committee. Staff at the Kawartha-Haliburton Source Protection Authority have since been working with the City of Kawartha Lakes to identify a replacement member. Once a member has been identified, the process of collecting municipal council resolutions in support of this new member will begin so they can be officially appointed to the Committee.
